LIFETIME COMBINATION HUNTING/FISHING LICENSE, \$775.00 (SENIOR CITIZEN COMBINATION, \$25.00)

As the owner of a lifetime combination license, you may hunt and fish in the State of Oklahoma for as long as you live, subject to the rules set forth for the separate hunting and fishing licenses described below.

LIFETIME HUNTING LICENSE, \$625.00 (SENIOR CITIZEN HUNTING, \$15.00)

Lifetime hunting license holders are exempt from purchasing an annual hunting license; Oklahoma waterfowl stamp; Wildlife Conservation Passport; deer, elk, antelope, and turkey licenses; and controlled hunt permits. The Online Check Station will allow you to print any necessary carcass tags when animals are checked in. Bobcats require a federal tag which may be obtained from Oklahoma game wardens, Department biologists, Department field offices, or specially designated stations at no charge. The lifetime hunting license does not exempt the holder from purchasing a bear license, H.I.P. permit (ages 16 to 64), federal permits, federal fees that may be required (such as a federal duck stamp or federal controlled hunt user fee), or a land access permit for designated areas. If the license holder hunts migratory birds, he/she must fill out a yearly migratory bird survey (HIP permit). The HIP permit may be obtained free of charge at www.wildlifedepartment.com or it can be purchased at a license dealership for \$3.00.

LIFETIME FISHING LICENSE, \$225.00 (SENIOR CITIZEN FISHING, \$15.00)

Lifetime fishing license holders are exempt from purchasing an annual fishing license. The lifetime fishing license does not exempt you from having to purchase a Lake Texoma license if you fish on the Texas side of Lake Texoma (unless age 65 or over), a land access permit for designated areas, or a **paddlefish permit**.

REQUIREMENTS TO QUALIFY

Only legal residents of Oklahoma for six months preceding application date, who intend to remain permanent residents of Oklahoma, may obtain a lifetime license. Any resident of Oklahoma who reaches 64 years of age shall be eligible for the senior citizen lifetime license during the calendar year in which said person turns 65 years of age. Any resident of Oklahoma born before January 1, 1923 is exempt from purchasing a hunting and/or fishing license and receives the benefits of the senior citizen lifetime license. The last four of the social security number is **required** to purchase a lifetime license.

Documentation proving residency must be presented for approval, such as:

- If 18 & over, an Oklahoma Driver's License or ID Card at least 6 months old.
 - If under 18, a parent or legal guardian's Oklahoma Driver's License or ID Card at least 6 months old.
 - Note: Additional residency documentation may be required.

A lifetime license holder, whether it be combination, hunting, or fishing, will not lose the benefits of the license by a change of address, even if he or she ceases to be an Oklahoma resident by moving out of the state. If you move, you should report your new address to our office.

APPROVAL If ordered by mail, Lifetime and Senior Citizens Lifetime License <u>applicants must mail in a copy of their Oklahoma Driver's License or State ID</u> for approval of the application. Disabled Veteran Lifetime License <u>applicants must mail in a copy of their Oklahoma Driver's License</u> as well as their Award Letter from the VA stating their disability rating for approval of the application.

PAYMENT Cashier's check, personal check, money order, Discover, Visa, or MasterCard.

REPLACEMENT If the lifetime license is lost or you need a replacement, a duplicate license card may be issued for a fee of \$6.00. Replacement cards may also be ordered online at license.gooutdoorsoklahoma.com.

All lifetime licenses are **non-transferable** and must be obtained by mail, in person, or online from the Oklahoma Department of Wildlife Conservation at the address listed above.
