(1) Skid Unit with following specifications: 250 gallon polypropylene tank with lifetime warranty will be provided. The tank will be constructed of 1/2" thick polypropylene sheet stock. The material shall be a non-corrosive stress relieved thermo-plastic, and U.V. stabilized for maximum protection. The transverse swash partitions shall be manufactured of 3/8" polypropylene, and extend from approximately 4" off the floor to just under the cover. The longitudinal swash partitions shall be constructed of 3/8" polypropylene and extend from floor of the tank through the cover to allow for positive welding and maximum integrity. All partitions shall be equipped with vent and air holes to permit movement of air and water between compartments. The partitions shall be designed to provide maximum water flow. All swash partitions interlock with one another and are welded to each other as well as to the walls of the tank. There shall be one (1) sump standard per tank. The tank shall have a combination vent and manual fill tower and sight gauge. The fill tower shall be constructed of 1/8" thick polypropylene and shall be minimum dimension of 8" X 12" outer perimeter. The tower shall have a 1/4" thick removable polypropylene screen and a polypropylene hinged-type cover. Polypropylene hose reel runners will be provided on top of tank to mount a hose reel. The complete skid unit will be mounted on 3" heavy duty aluminum frame for easy transfer from vehicles.

NOTE: TANK WILL BE MADE AT THE LOWEST PROFILE POSSIBLE.

PUMP AND PLUMBING: The pump will be a CET-18HP HND-MR powered by a 18HP Honda engine. The pump will have electric start, manual recoil backup, and exhaust primer. An aluminum lighted control panel with liquid filled pressure gauge, start, stop, choke, and throttle will be provided at the rear for easy access at ground level. One (1) 2 1/2" suction with 2 1/2" stainless steel valve for drafting and hydrant capabilities will be provided at the rear with 2 1/2" chrome plug and chain. One (1) 2 1/2" stainless steel valve will be provided from tank to pump. A stainless steel common manifold will be provided to help prevent friction loss. A permanent 3/8" recirculating line will be provided with a valve off the pump motor to turn off per department specifications. One (1) 1 1/2" discharge with 1 1/2" stainless steel valve will be provided and plumbed out the rear with a chrome cap & chain. Three (3) discharges with 1" stainless steel valves will be provided as follows; one (1) will be plumbed as the tank/fill recirculating line, one (1) will be plumbed to the hose reel and one (1) will be plumbed out the rear with a chrome cap and chain. All valves will be stainless steel. All connections shall have NST fire thread. All plumbing will be heavy duty stainless steel. The plumbing shall not be completely rigid for ease of disassembly. A six (6) gallon fuel tank will be provided for the engine. All welding will be done by certified welders. A heavy duty automotive battery will be provided, so the unit will be self contained. THE STAINLESS STEEL PLUMBING WILL HAVE TEN (10) YEAR WARRANTY.

HOSE REEL: One (1) Hannay 4000 Series low profile electric hose reel will be provided. The hose reel shall have electric rewind that is controlled by a push button on driver & passenger side of skid. The hose reel shall have a dual roller and spool assembly. The reel shall have 150' of 3/4" 800 PSI booster hose. The entire hose reel assembly will be mounted on top of the tank.

NOZZLE: Two (2) Pistol Grip TFT Quadra FOG DQS 40, or equivalent, with adjustable gallonage from 5-10-24-40 with bell shut off and able to go from straight to wide fog to flush without shutting down.

Additional: One (1) 15' X 1" Whip line will be provided and coupled on both ends.
