## OKLAHOMA RESIDENT SENIOR CITIZEN LIFETIME LICENSE APPLICATION

Senior Citizen Lifetime licenses are available to legal residents of Oklahoma who are (or will become) 65 or older during the current calendar year. To prove residency, please provide a copy of your Oklahoma Driver's License or Oklahoma State ID. Residency status is determined by the state in which you hold your Driver's License or State ID. Applicants with an out of state Driver's License or State ID do not qualify for the Resident Senior Citizen Lifetime License. Applicants must hold an Oklahoma Driver's License or Identification Card for at least six months from the *original* issue date to meet residency requirements.

Lifetime licenses are available online, by mail, or in person at ODWC headquarters in Oklahoma City. For mail-in orders, please allow up to four weeks for processing. License may be purchased with a money order, cashier's check, credit card, or personal check.
