### **General Requirements**

This proposed contract is for the removal of approx. 21,227 feet of barbed wire and woven wire fencing on Barren Fork WMA. Project will involve use of a rubber tracked skid steer to remove corner posts, T-posts and wire that currently inhibit movement of wildlife and add un-needed debris to the floodplain of Barren Fork Creek.

- Remove approx.. 21,227 feet of barbed wire and woven wire fencing and associated T-posts, corner posts, stretcher posts and coral structure from the Barren Fork WMA.
- Fencing sections are marked on the attached map.
- All materials must be completely removed from the WMA, unless directed otherwise by ODWC personnel.
- Equipment must be equipped with rubber tracks
- Vendor can mow/clear brush immediately next to fencing with equipment for access where necessary, except for areas immediately adjacent to the stream in the floodplain.
- No removal of standing trees larger than 3" diameter at breast height (DBH) between May 15<sup>th</sup> and July 31<sup>st</sup>.
- Any large holes created by removal of posts should be filled to reduce hazards to WMA users.
- Wooden posts immediately adjacent to the "Cline Barn" will be left in place and equipment will be kept 50 ' from structure.
- Barren Fork Creek can become uncrossable during rain events. Plan accordingly.

Contract Specifications: Contractor is to provide all equipment, tools and labor needed to complete the work as required.

Mandatory Pre-Bid Meeting: A mandatory Pre-Bid Meeting will be held on <u>April 17th</u>, 2025, at 11:00 AM CST. All contractors must attend the Mandatory Pre-Bid meeting to bid on this project. Meeting address: 473718 E 763 Rd. Westville, OK 74965. GPS coordinates for this meeting location are <u>35.91394, -94.58800</u>. From this location vendors will travel into the WMA to view fencing. Bidders arriving late may not be eligible to bid, and cell service is poor in this area, so please find directions to the meeting location before meeting date and arrive on time.

Project must be completed within 90 days of contract award. All work will be done as directed by the ODWC Area Biologist or ODWC Area Technician.

Please note that this will be awarded as a Binding Contract.

Contract will be awarded to one contractor only. If the contractor is awarded multiple ODWC projects, contractor must be capable of completing each project simultaneously.

Insurance: The successful bidder will be required to provide certificates of insurance for general liability, vehicles and work compensation immediately upon notification that they are the successful bidder. A contract will not be issued without the required proof of insurance.

Basis of Contract: The determination of the Lowest Responsible Bidder will be made based on the lowest bid submitted.

The Owner reserves the right to make any inquiries to ensure that the lowest bidder can complete the work in a satisfactory manner.

The contract will be issued by the Office of Management and Enterprise Services, Construction and Properties Division (OMES/CAP). The contractor shall not begin work until the contract is in place and written notice to proceed has been issued by OMES/CAP.

Terms and Conditions: As stated in the contract.

Change Order: This will be a Binding Contract.


Scheduling: Provide Agency Representative with proposed work schedule prior to beginning work.
