#### **Project Overview**

This project involves disking designated wetland units to enhance habitat quality, promote native wetland vegetation, and control invasive species. Disking will disturb the soil surface to encourage seed germination, reduce existing undesirable plant competition, and improve habitat conditions for waterfowl and other wildlife. This document outlines the expectations, equipment, and specifications for disking wetland units on Grassy Slough Wildlife Management Area for 2025.

#### Scope of Work

#### **Basis of Contract**

- Determination of the lowest responsible bidder will be made based on the lowest extended price (acres x price).
- ODWC reserves the right to make any inquiries to ensure that the lowest bidder is capable of completing project in a satisfactory manner.
- The contract will be issued by the Office of Management and Enterprise Services, Construction and Properties Division (CAP). Contractor shall not begin work until the contract is in place and written notice to proceed has been issued by (CAP).
- Contractor will be required to provide certificates of insurance for general liability, vehicles and worker compensation (if applicable) along with bonds listed in the project manual general conditions immediately upon notification that they are the successful bidder. A contract will not be issued without the required proof of insurance.
- Terms and conditions will be stated in issued contract.

#### **Site Description & Operating Window**

- Approximately 200 acres of drawn down (dried) wetland units to be disked between 07/01/2025 09/30/2025.
- Wetland units located on Grassy Slough WMA, owned and operated by the Oklahoma Department of Wildlife Conservation (ODWC): T9S, R24E, Sections 11 & 12
- See attached maps for project site location and wetland units to be disked.

#### Equipment, Credentials, and Skills Required

- Utilize and follow project maps indicating disking zones, access routes, and areas to avoid.
- Clear and open communication with overseeing WMA biologist on work periods and arrival/departure from project site.
- Skilled and experienced using heavy equipment and implement safely and effectively.
- Minimum equipment requirements: 120 horsepower tractor and 12-foot primary tillage disk.
- Equipment that has low-ground-pressure tires to minimize soil compaction preferred.
- GPS-enabled equipment for precise disking patterns to ensure uniform coverage preferred.
- Contractor is responsible for all labor, materials, supplies, equipment, fuel, equipment maintenance, tools, safety equipment (e.g. PPE), transportation, and supervision.

#### **Project Specifications**

- Disk to 4-6 inches to maximize disturbance of invasive species' root systems and promote native seed germination. The goal is to chop and mix existing vegetation.
- Conduct **3 passes** with the primary tillage disk over all 200 designated acres to ensure thorough soil disturbance and uniform coverage, adjusting disk angle or weight as needed for consistent depth.
- Disk in a pattern (e.g., parallel or crosshatch) to achieve even disturbance while avoiding overcompaction or damage to wetland hydrology.
- Avoid disking and transport during excessively wet conditions to prevent rutting or damage to wetland structure and roads.

#### **Environmental and Safety Considerations**

- Adhere to all state and federal environmental regulations.
- Ensure operators are trained in safe equipment operation and understanding of wetland-specific protocols preferable.

#### Timeline

- Over-the-phone inquiries and scheduling voluntary pre-bid meetings may be done directly with the overseeing WMA biologist (contact info on previous page).
- Entire project is limited between months of 07/01/2025 09/30/2025. Narrow window between draining wetland units dry enough for disking and refilling for waterfowl season.
- **Pre-Disking (1-2 days):** Transport and deliver equipment to project site. Complete any discussions with WMA biologist to finalize plans.
- **Disking Operations (8–14 days):** Conduct three passes over designated acreage, with duration based on unit size and weather conditions.
- **Post-Disking (1-2 days):** WMA biologist inspection and approval, discussion of any damage concerns, document completion, and remove equipment from site.
- Total estimated duration: 10–18 days, depending on weather and equipment.

#### **Project Outcome Expectations**

- Completed disking of designated wetland units, using **3 passes** with primary tillage disk at **4-6 inches deep** on approximately **200 acres**. Existing vegetation should be chopped and mixed thoroughly.
- Roadways, levees, and any property of ODWC shall be left undisturbed, with no rutting or other damages from equipment or transport.

#### **Assumptions and Constraints**

- Seasonal weather conditions will allow access to wetland units without significant delays.
- Site access is available via existing roads or paths suitable for heavy equipment and transport.

#### **Roles and Responsibilities**

- **Contractor:** Provide equipment, labor, and expertise to perform disking (three passes, specified depths); ensure compliance with safety and environmental standards.
- WMA Biologist: project meetings, coordinate with contractor, review progress, and report outcomes.


### **Budget Considerations**


