Further Clarification: This is the Bear Creek Mulching Project, that is in the Kaw Lake Wildlife Management Area (WMA) that needed further clarification.

Trees between or in the fenceline do not need to be cut, only trees east and north of the mowed path withing the polygon.

Dead trees 10" and larger can be left standing in the unit.

Down trees do not need to be mulched up, they are more than welcome to if they want but not required.

Description of Amendment:

a. This is to incorporate the following:

Clarification: This project is trees 10" and larger left on the site (and all cedar trees removed). Trees 6" and greater must be felled and all limbs removed. So what this means is trees greater than 6" up to the 10" maximum of tree size must be cut and limbs removed. Trunks left in place and nothing in the area over the 6" height from the ground.

No need to stack trunks or haul any material off. ODWC will burn the mulch layer off this summer.
