090A SCOPE OF WORK

Mastication and Clearing of Woody Vegetation San Bois Wildlife Management Area (WMA) Area is located in southeast Haskell CO, near the town of McCurtain

GENERAL REQUIREMENTS

Project 1:

1.

Mulching of encroaching vegetation along overgrown roads. Vegetation consists of pine and hardwoods.

All trees and brush under 10" should be taken down to ground level and mulched with no stumps over 2" above ground level. Exact location on WMA to be determined by area personnel.

Equipment requirement s: Rubber track or wheeled, 140hp minimum, with fecon or equivalent style mulching head. Must include operator.

Project 2:

Expansion of roadside/fireguard clearing up to 30' from existing road/fireguard by removal of all woody vegetation under 10". Stumps and all vegetation to be mulched as close to ground level as the terrain allows. Exact location on WMA to be determined by area personnel.

Equipment requirements: Excavator, 69hp minimum, with drum style mulcher. Must include operator. Contract specifications:

Vendor is to provide all labor and needed equipment to complete the work as required. Operator will not be compensated for time spent on maintenance and repairs of equipment, including fueling of machine. Operator must be able to get fuel to machine, or notate hours spent in transport to fuel (hours to be subtracted from project total).

Project must be completed within 90 days of contract award and or by May 31 at the latest. All work will be done as directed by the ODWC Area Biologist or ODWC Area Wildlife Technician.

Please note that this will be awarded as a Non-Binding Contract. The number of hours is an estimate only, and they may increase or decrease depending on total bid per hour. As such, the contract will be awarded based on the bid per hour for the total price allotted.

Contract will be awarded to one vendor only. If the vendor is awarded multiple ODWC projects, they must be capable of completing each project simultaneously.

Insurance: The successful bidder will be required to provide certificates of insurance for general liability, vehicles and worker compensation in the amounts specified in the contract immediately upon notification that they are the successful bidder. A contract will not be issued without the required proof of insurance.

Basis of Contract: The determination of the Lowest Responsible Bidder will be made based on the lowest extended price (# of hours x hourly price).

Oklahoma Department of Wildlife Conservation reserves the right to make any inquires to insure that the

lowest bidder is actually able to complete the work in a satisfactory manner. The contract will be issued by the Office of Management and Enterprise Services, Construction and Properties Division (OMES/CAP). The Contractor shall not begin work until the contract is in place and written notice to proceed has been issued by OMES/CAP.

Failure to submit a complete bid, inclusive of all requested information, may disqualify the bidder.

Terms and conditions: As stated in the contract.

Change Orders: Changes in the work shall not be undertaken without prior written authorization. Field personnel are not authorized to modify the scope of work in any way or to issue change orders to this contract. Contractor shall submit a written request for a proposed change, the reason for the proposed change and the increase or decrease in price and time required as a result of the change. Cumulative changes that exceed the original contract price by more than 15% are prohibited by Oklahoma law. Bids are invited as stated on the solicitation cover sheet and must be returned by the date and time specified. Late bids will not be considered.
