The proposed contract is for the building of a permanent pump station and installation of pump unit on the Webbers Falls WDU in Muskogee County, Oklahoma.

General Project Overview: Excavate, install and cover pump, intake and water delivery pipeline, place and install water control structure, place 5¿ surge rock and 24½ rip-rap according to design plans. Will require the use of a long reach excavator with a minimum reach of 60¿ (feet), telescopic track (8,000 pound lift cap), wheel loader with a minimum 4.5 yard heaped bucket, and onsite capabilities to lift, place, weld 18¿ steel pipe and install 15¿ plastic pipe.

Project work will consist of: Building a jetty and underwater pad by excavating and placing both 5¿ surge rock and 24½ rip-rap horizontal and on a 1:1 slope out into the Arkansas River, and placing/installing a pump intake (roughly 30 feet of the 42¿, 18¿ steel pipe with pump attached will be installed underwater) according to design plans. Excavating, welding and installing approximately 105¿ of pipe (both 18¿ steel, and 15¿ plastic) and water control structure with rip-rap splash pad on grade according to design plans.

Additional Details: All materials for installation will be provided and onsite for use. This solicitation is for the equipment and labor portion only to complete the project. See the attached design plans at the end of the solicitation. Please note the design change on the intake portion of the project (final page).

Location of the job site will be on the Webbers Falls WDU, located near Braggs, Oklahoma in Muskogee County. Rough directions are as follows: From State Highway 10, go West on County Rd. E0930 (Davis field Rd., North side of Braggs) approximately 2.5 miles, the road will dead end at job site. All work will be done as directed by the ODWC area biologist.
