License may be purchased with a money order, cashier's check, credit card, or personal check. If you pay with a personal check, the LICENSE WILL BE HELD FOR THREE WEEKS. ** The Payment Plan Option is available to sportsmen under 18, with the first and last payments requiring residency approval. Minimum payments are \$25 and the balance of the license is due 12 months from the date of the first payment. After 12 months, any prior payments will be forfeited.
