

Wildlife Rehabilitation Application Process

Attached is a copy of the Wildlife Inspection Form. Before you fill out the online application, please contact your [county game warden](#) to make arrangements to do the inspection. Once the inspection is complete, log into the new license system at www.gooutdoorsoklahoma.com . Please use the following instructions:

1. Choose "Licensing"
2. Login, enter your date of birth, last name and last 4 numbers of Social Security number, then "Continue"
3. Certify or Edit your information
4. Choose "Purchase License" (upper left side- picture of deer)
5. Click on "Recreational License"
6. Scroll down to "Specialty License"
7. Choose "2235 - Application for Wildlife Rehabilitation License"
8. Click on +Add to Cart
9. Click on Cart Icon at top of page
10. Choose "Checkout"
11. Fill out the application, upload the game warden signed Inspection Form
12. Choose "Submit"
13. Answer Affirmation Questions, then Process Order
14. Transaction Confirmation, gives you option to print

There won't be a payment required at this stage. Once the application is submitted for approval you will receive an email confirming the application submission. When the application is approved or requires more information you will receive an email confirmation of approval or other instructions. Once approved, go back into your profile and submit the payment. NOTE: There should be no delay if the required document is uploaded into the application (Completed and signed Inspection Form by the county game warden)

Important to Remember:

You will need to have the facility constructed for the type of animals you want to rehabilitate and then call the game warden in your county to inspect your facility. It is your responsibility to become educated in the care of the animals you want to rehabilitate and to finance the care of the animals.

If you want to rehabilitate any birds other than common pigeons, house sparrows, starlings and upland game birds: such as, quail and pheasants, you will also need to have a Federal Special Purpose Rehabilitation Permit or Federal

Rehabilitator Migratory Bird and Raptor Permit. You apply for that license with the **US Fish and Wildlife Services**, Migratory Bird Office, P.O. Box 709, Albuquerque, NM 87103-0709, phone 505-248-7882.

If you have moved from the original inspected facility site, you do need the game warden to inspect your new location.
